One issue is with meshes that have the same material assigned to two meshes on top of each other. The edge shader is applied to the vertex on the bottom mesh, but for some reason the face

shader on the top mesh is not working. How do I get this fixed? . Another issue I have is with my mouse if I was using the left hand to control my camera. While . the top hand was able to change camera angles, the camera would not turn left or right. The mouse was stuck in the up position. . It was fixed in 4.2.0, but I have not been able to figure out how to get that kind of mouse support back. I found a few posts from back in April which talked about a mouse support fix, but I could not find anything after that, and I am hoping that I might have discovered that solution during the time I was unable to use the mouse with my camera. . I need to ask because the mouse support might be a very big issue for some people. Can somebody give me a hand with this if it is fixed and it works as intended? . I would greatly appreciate any help. . Thanks! I've been trying to make a 2D rig for my game (essentially a maze with blocks) using Blender and I need to understand how the matrix stacks up, I'm not sure what I'm doing wrong, if you could point me to any online tutorials that would be helpful. The reason I don't want to import an object for the background is that, in my game, there's a character, the player, and the character spawns at an arbitrary location, so the player won't be on a

static background anymore, but on a character rig. Then, from this point, I want to get the character's rotation, so I can rotate the background. I think I have it all figured out, from there, I can use the.obj file to create blocks, and just use the matrix to move and rotate them. But, I can't get the matrix to rotate for the background, and I'm not entirely sure how I'd do it in another way. Basically, I want to move the background to the "right" (x value direction), based on where the player is. I'm assuming this is the most efficient way of doing it, but I

First of all, it's a free to use product. You're no

longer limited to one free per machine or lifetime. And there's no ads. You can also get version 4 for free too. The 4.2.1 version is very new. It can also trigger bugs still, but they're very rare. I was using v.3, then I opened v.4 and it worked fine right away. So now I'm using v.4 instead. Here's an image of the bug I'm talking about: In 2D, no problem. But there's an issue in the project file. If you edit a model made with v.3, and go into Project Options on the "Configure" tab, you'll see this and all the other settings of v.4 are greyed out. So you can't save it. But this really shouldn't be a problem, because you can delete the v.3 project file, then open it in Simplify3D v.4. So, if you accidentally opened a model made with an older version, you should be able to rectify the problem. Thank you, and sorry for taking up a lot of your time with such a basic (and probably easy to solve) issue. I'll ask a staffer to keep an eye out for any problems, but please let me know if you run into any problems with these newer versions. Thank you again. What's this?
